Abstract:

The Betawi language, akin to many global languages, is on the brink of fading due to various factors, one being the evolution of civilization. This decline jeopardizes several facets of the native Betawi culture. Hence, efforts to maintain and preserve the Betawi language are imperative. The challenge lies in understanding the extensive scope of Betawi's linguistic and textual context. Thus, it's crucial to develop a targeted strategy that pinpoints the primary elements influenced by the degradation and endangerment of the language, particularly in the Betawi community. This study identifies these elements after extensive on-field research, spanning over a year with round-the-clock observations. The research found that a sociological qualitative analysis, especially focusing on society's social evaluation, is the most effective method. Consequently, five key areas were identified to analyze the repercussions of the language's decline: linguistic aspects, individual identity, inter-generational communication, knowledge transfer, and economic implications.

The repercussions of a language's demise go beyond its immediate speakers, touching broader spheres such as cultural richness, societal cohesion, mental well-being, and repositories of knowledge. The impact on a society, when a language fades, can be compared to an organism losing an essential organ central and potentially catastrophic.

The end of a language often precipitates a deep crisis of identity among its users. This void can usher in feelings of cultural detachment, loneliness, and sorrow akin to losing someone close. Such emotional responses can manifest into tangible mental health challenges like anxiety, despondency, and an overwhelming sensation of void.

The extinction of a language often leads to the disruption of social structures and community cohesion. Without a common language, communities may become more fragmented, with members increasingly identifying with larger, often more dominant, cultural groups. This

This analysis aims to delve into the profound impact of language extinction on communities around the world. Specifically, this study aims to identify and determine which factors need to be assessed and examined to understand the consequences of the deterioration and potential extinction of the Betawi language on its native speakers. It's worth noting that the Betawi language, given its context and heritage, may very well be approached differently than other languages. This distinction arises from its unique attributes, distinctiveness, and intricacy.

II. Review of Literature

The endangerment of a language impacts more than just the spoken words; it deeply affects its speakers. When a language fades, a significant portion of the community's cultural essence fades with it. The loss of a language can be perceived as a loss of social identity or even as a mark of subjugation, regardless of whether the loss is by choice.

Languages serve as vessels for human legacy, often encapsulating cultural rituals, hymns, verses, and narratives. As languages fade, these elements can fade too, especially when such traditions and tales struggle to find a fit in another language. This shift can influence the speakers' sense of self and can dilute community bonds as original values and practices give way to newer ones. Language is more than just a means of communication; it's a powerful emblem of

a community's identity, with a vast expanse of cultural, spiritual, and intellectual experiences intertwined within it.

Languages contain an accumulated body of knowledge. A community's history is passed through language, so when the language disappears, we may lose important information about early history or nature. Therefore, we lose ancient knowledge when we lose languages.

Languages are ways of interpreting the world. Different languages provide different pathways of thought and frameworks for thinking and solving problems. Some things just cannot be expressed the same way in a different language.

Bamghose, (1993, p. 3) claims that even though the concept of language endangerment is taken as a given fact there is no uniform definition of endangered languages, the most obvious definition is by several speakers.

A language with fewer speakers is more likely to be endangered if compared with larger languages. Speakers of such languages tend to learn another language (more widely spoken) for interaction outside their immediate community, where language loyalty is not strong; it is a short step to language shift and eventually language death.

Machinyanse, (2018, p. 2) argues that the most widely affected languages by language endangerment are minority languages as a result of certain factors; globalized economies and media are the most prominent social factors that successfully change the cultural landscape of the entire globe affecting negatively the languages human speaks. It is a clear fact that indigenous languages whose speakers are affected directly by these modern global trends are on the verge of extinction. Other factors are cultural political/economic marginalization and hegemony, this happens when political and economic power is closely linked to a particular language and culture so much that there is a strong incentive and benefit for individuals who use the privileged language, this compels speakers of minority languages to abandon their languages in favour of another more prestigious one. Simon and Charles (2020) maintained that language endangerment is a serious concern to linguists and language planners.

Language planners have turned their attention in the last several decades for a variety of reasons, speakers of much smaller fewer dominant languages stopped using their heritage language and began to use another. Parents may begin to use only the second language for their children and gradually the intergenerational transmission of the heritage language is reduced and even ceases. Therefore, there may be no speakers who use the language as their first or primary language and eventually, the language may no longer be used at all. A language may become dormant or extinct, existing only in recordings or written records and transcription. Languages that have not been adequately documented disappear altogether.

The Betawi language is important as it influences Bahasa Indonesia, our national language (Ikranegara, 1980). The influence was reflected in published newspapers, movies, short stories, political satire, and so on. Ikranegara (1980) further argued that the Betawi language influenced Bahasa Indonesia phonologically or syntactically. The instances of the influence are the words that have final [e] often appear where standard Bahasa Indonesia has final [a] or schwa appear in final syllables where Bahasa Indonesia has [a] such as “ade” (have) or “dating” (come).

However, the Betawi Language is threatened to be extinct since the number of users is decreasing day by day. Then some efforts are considered to take particularly from the local

language field. Betawi language is taught and also included in the school curriculum in Jakarta. Movie, art performances, and short stories that use the Betawi Language is produced (Si Doel Anak Sekolahan, Lenong in district areas in Jakarta, and Portal Betawi are examples).

Production of word prosody in Betawi Malay which focuses on the way an accent is realised in Betawi Malay has been analysed by Heuven, Roosman, & Zanten (2008). They found that the accent may fall on pre-final or final syllables in Betawi Malay.

III. Research Method

In the chapter that follows, our research team will devote considerable attention to the analysis of the amassed data. This data was primarily sourced from two fundamental techniques: meticulously conducted in-depth interviews and detailed questionnaires that were filled out by participants. The overarching goal of our research centres on gaining a deep understanding of the Betawi language.

To ensure a multifaceted understanding and capture a multitude of perspectives, our team selected participants with a wide age bracket ranging from youthful participants as young as 6 years old to more mature individuals up to 48 years of age. This deliberate selection is instrumental in capturing an array of opinions, encompassing both contemporary and traditional thoughts about the language.

Given that the nature of the data collected for this study is qualitative; our research methodologies aligned with qualitative research paradigms. Citing Nunan's work from 1992, it's established that a qualitative approach fundamentally emphasizes the intricate processes of description and scrutiny, which culminate in research outcomes. In the realm of qualitative methodologies, the utilization of written artefacts such as diaries, journals, blogs, essays, and various opinion or reaction pieces is common. These can be sourced from both traditional paper-based formats and modern online platforms, as articulated by Harklau in 2011. While qualitative research predominantly employs verbiage for data representation, it's noteworthy, as suggested by Frankel & Wallen in 2006, that statistical data can also be harnessed to bolster and substantiate research findings.

The research tries to read the main segments that must exist and are sufficient to fulfil the study of the impact of shifting degradation, or extinction of a language on the community. In the context of the Betawi language, consideration of the dynamics of past, present and future civilizations are vital to be included as research parameter variables. Thus, this research which has been carried out intensively for about 18 months (24 hours a day) has obtained maximum results in its conclusions.

In light of the comprehensive research undertaken, we've identified several distinct segments, critical variables, and essential parameters that are imperative when evaluating the repercussions of the declining proficiency and endangerment of the Betawi language within the societal context. Upon detailed examination, every single one of these facets emerged as pivotal in gauging the said impact.
